## Older Adults without Family or Friends Lag in the Race to Get Vaccines

There seems to be a divide between the "haves" and "have nots" emerging as older adults across the country struggle to get COVID-19 vaccines. Older adults who are comfortable with computers and have internet service are getting notices of vaccine availability and can register online for appointments. Those who can't afford broadband services or don't use computers or smartphone apps are likely missing out on information about vaccines and appointments.

Yavapai County Community Health Services has a fully staff phone bank Monday through Friday 8:00 to 5:00 p.m. to assist eligible residents on how to make an appointment via our website (<a href="https://www.yavapai.us/chs/Home/COVID-19/Vaccine">https://www.yavapai.us/chs/Home/COVID-19/Vaccine</a>), or to help those without internet by making appointments. They've also been able to provide resources for transportation to/from scheduled appointments. It's important to note, that for the points of distribution at Findlay Toyota, the old Sears building at Gateway Mall, and the Verde Valley Christian Church in Cottonwood, appointments are mandatory. There are no walk-ins.

## **Update on Vaccine in Yavapai County**

Leslie Horton, Director of YCCHS was able to acquire 1,100 doses in addition to the initial 9,400 dose allocation from the state bringing the county total to 10,500 doses of COVID-19 vaccine, which should be delivered by tomorrow.

Yavapai County has tested **97,053** residents with **16,932** positive cases, **7,007** recovered, and **403** deaths. YRMC West has **31** COVID-19 patients, YRMC East is caring for **9** patients. VVMC reports **17** COVID-19 hospitalizations. The VA reports **1** COVID-19 patient today.
